To All Nagoya University Students Regarding Overseas Travel

Due to the spread of the novel coronavirus, Nagoya University is implementing the following regulations to protect students and other members of the community. We ask for your understanding and cooperation.

Please cancel or postpone any overseas travel

Should overseas travel be absolutely necessary, make sure to:

- ①Input your data into the overseas travel database
 - https://tokou.iee.nagoya-u.ac.jp/ (available only in Japanese)
- ②Notify your school/department by printing and submitting the overseas travel notification form from the travel database
- ③ Japanese citizens only Register in "tabireji" https://www.ezairyu.mofa.go.jp/tabireg/index.html (available only in Japanese).

If you travel through a Nagoya University study abroad program, please contact your supervisor.

- Should you be infected with the novel coronavirus and be unable to return to Japan, contact your school/department and the Student Exchange Division immediately (corona@adm.nagoya-u.ac.jp).
- Students entering Japan from a country with a Travel Advisory and Warning must quarantine themselves at home for two weeks.

"Countries with a Travel Advisory and Warning" are those the Ministry of Foreign Affairs identifies in the Level 2 (avoid non-essential travel) or higher category at risk of infectious disease.
