Full-time 10-year term, with a possibility of renewal depending on the evaluation.

6. Qualifications

- The successful applicant will have a high level of knowledge, insight, and outstanding achievements in basic medicine, and will be a key leader in education and research at the graduate and undergraduate levels in fields related to the applicant's specialty.

The applicant will belong to the Center for Neurological Diseases and Cancer, but not specialize in the fields of Neurology or Oncology, nor be limited to a specific field of research.

We are seeking a researcher who will be involved in basic medical research and who will facilitate collaborative basic/clinical research on campus.

- Teaching experience is not an absolute requirement, but experience in

medical education is expected.

- The period of tenure as a professor must be appropriate in order to contribute to the development of education and research in the relevant specialty.
- If the candidate's performance (including research achievements, educational achievements, and social contributions) and character are deemed equal, a woman will be accepted.

- 6) Educational achievements and aspirations (free form): Please write within 1,000 words, including teaching experience and courses you have taught.
- 7) Research achievements and aspirations (free format): Please write within 1,000 words.

We are currently accepting applications for the position of Professor, Graduate School of Medicine, Nagoya University. Supplemental information will be provided.

1. Position and number of positions

One Professor (tenured) is sought. The faculty positions in the department are one Associate Professor, one Assistant Professor, one Designated Assistant Professor (maximum term of 4 years), and one Postdoctoral Fellow (maximum term of 3 years). One postdoctoral fellow is eligible for appointment approximately every five years. Currently, one Designated Assistant Professor (maximum term of 4 years) is vacant, other positions may be available in the future.

2. Research space

The Professor office (24.5 m²), the office for laboratory members (59.5 m²), and the research laboratory (252 m²) will be provided in Medical Science Research Building 2. In addition, the Division for Medical Research Engineering (Research Core Facility) is equipped with both basic and state-of-the-art instruments for your use.

3. Fields of education and research for the position

We are looking for a basic medical researcher in a wide range of fields, not limited to Neurology and Oncology. The applicant must be a basic medical researcher who can facilitate basic/clinical collaborative research on campus.

4. Educational Responsibilities

<Graduate School> Education responsibilities are based on the area of specialization.

<Medical School> Education responsibilities are based on the area of specialization.

5. Points to be noted when applying

6. Expected starting date: April 1, 2024 or later

7. Employment Status: Full-time (10-year term), with contract renewal after 10 years upon review, and indefinite employment thereafter until retirement (end of the fiscal year in which the applicant turns 65 years old).
