It should provide the applicant’s e-mail address as well as telephone number. The applicant is not required to specify one’s gender nor affix one’s photograph if one does not wish to do so.);</li> <li>2) A list of publications. (If an applicant has won any competitive research grants in the past, please mention them here with information on their amount and source) ;</li> <li>3) Copies of three publications (books or journal articles), in English or Japanese;</li> <li>4) A short essay describing how an applicant wishes to conduct teaching and research activities at the Graduate School of International Development (approximately 1200 words in English or 3000 characters in Japanese) ;</li> <li>5) A course syllabus if you were to offer the course entitled “Rural Development in Developing Countries,” in both English and Japanese, each in one or two A4 pages. (The syllabus should describe the course objective(s) and structure as well as topics for fifteen classes.
