The title of the e-mail should read "Application for the Associate Professor of Poverty and Social Policy Program."</p> <p>Application documents should include:</p> <p>1) A curriculum vitae (There is no fixed format. It should provide the applicant's e-mail address as well as telephone number. The applicant is not required to specify a gender nor affix a photograph.);</p> <p>2) A list of publications. (If the applicant has won any competitive research grants in the past, they should be mentioned here with information on their amount and source) ;</p> <p>3) Copies of three publications (books or journal articles) in English or Japanese;</p> <p>4) A short essay describing how the applicant wishes to conduct teaching and research activities at the Graduate School of International Development (approximately 1,200 words in English or 3,000 characters in Japanese) ;</p> <p>5) A potential course syllabus for a course entitled “Poverty and Social Policy” in both English and Japanese, 1-2 A4 pages each. (The syllabus should describe the course objective(s), structure, and topics for fifteen classes.
