

Job opportunity in the Institute for Space-Earth Environmental Research (ISEE),  
Nagoya University, Japan (ISEE job opportunity No.9 FY2025)

1. Job title/quantity: Designated Assistant Professor (1)
2. Employer: Tokai National Higher Education and Research System (THERS)
3. Affiliation: The Designated Assistant Professor belongs to the Center for International Collaborative Research (CICR) of ISEE. The Designated Assistant Professor will also belong to Integrated Studies Division
4. Field and Mission: The Institute for Space-Earth Environmental Research (ISEE) at Nagoya University seeks a designated assistant professor for research into the dynamics of the Earth's magnetosphere with two directions. One direction is to study transport and energization processes of ions and electrons in the magnetotail and inner magnetosphere based on analysis of spacecraft data from Arase (ERG) mission, for which ISEE operates the Mission Science Centers (Center for Heliospheric Science) in cooperation with JAXA/ISAS. Another direction is to study interhemispheric magnetic conjugacy directly related to the magnetic mapping between different regions, using the data from all-sky camera, induction magnetometer and riometer at Husafell near Tjornes in Iceland operated by ISEE in collaboration with National Institute of Polar Research (NIPR), and all-sky camera data from Syowa station in Antarctica (in collaboration with NIPR). The successful candidate is expected to have good background in physics and mathematics including statistics and data analysis and developed skills in using Python/MATLAB/IDL. Some background in space-plasma physics and data analysis of space-based data is preferred but not required. Knowledge of FORTRAN/C++ is a plus. A good command of English, or of Japanese plus fair English, is required. The designated assistant professor will be under the guidance of Prof. Yoshizumi Miyoshi (ISEE), Prof. Kazuo Shiokawa and Dr. Natalia Ganushkina (University of Michigan, USA/Finnish Meteorological Institute, Finland, also a Designated Professor at ISEE). The project centers on understanding the dynamics of charged particles in the electromagnetic fields in the Earth's magnetosphere and features of magnetic mapping which interconnects different regions of geospace.
